In 2006, CU2C2 operated on a cash basis with a fiscal year matching the calendar year. The attached Profit & Loss and Trail Balance statements contain certain expenses which must be paid by December 15, 2006, including payments for UU World advertising in 2007 and booth and workshop expenses for UUA 2007 General Assembly that are a significant part of the annual budget for 2006. We felt that omitting these pending payments would provide a misleading statement of CU2C2's financial position, so we opted to include them. The financial position of CU2C2 is still better than budgeted. We hope that you agree.

Association Membership – These are dues collected from member camps and conferences as of 11/20/06. This year was the best in recent memory for dues participation.

Individual Membership – These are dues collected from individual supporters of CU2C2. No special effort was made this year to pursue individual memberships as of 11/20/06

Interest – Payment of interest on balance in Heritage Checking account as of 9/29/06.

Administration – Compensation for CU2C2's part-time administrator. In 2005, with the approval of the delegates at the annual meeting, CU2C2 reestablished this position after several years of having no administrator. The part-time administrator we have hired for 2006 and, again, for 2007 is UU Rowe Conference Center.

Conference Support – Financial support for the annual conference, host site, speakers, and any scholarship requests for the annual conference.

General Assembly – Expenses related to GA booth, workshop, and promotions.

Outreach to Camps – A grant to a camp or conference. This year, the grant was to U Bar U.

Promotion & Advertising – This is the UU World ad in the Spring 2007 issue and printing costs for a poster to be distributed to congregations during 2006, 2007, and 2008.

All currency is shown in U.S. dollars. Payments from Canadian camps, conferences, and individuals are accepted at-par in Canadian dollars. This document contains forward-looking statements.
